



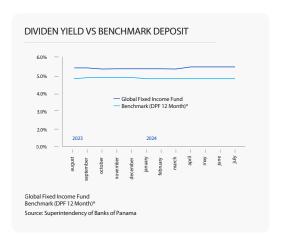

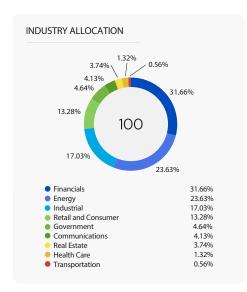
OBJECTIVE

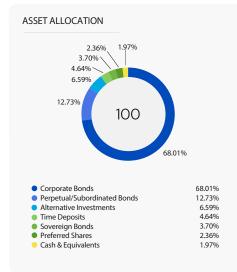

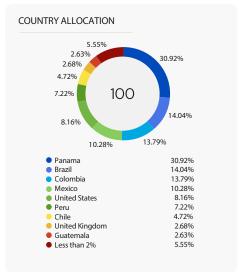

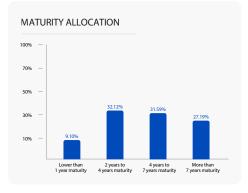
