Re: Notification of event that will materially and adversely affect the financial condition of ENA Norte and ENA Norte Trust

In compliance with clause 7.2 (e) of the Indenture Agreement among Empresa Nacional de Autopista, S.A., ENA Norte, S.A. and the Bank of New York Mellon as Indenture Trustee, and HSBC Bank (Panama) S.A., now Banistmo S.A., as Trustee of ENA Norte Trust pursuant to the Trust Agreement dated as of September 20, 2012.

Dear Ms. Coronado:

In compliance with the above referenced clause of the Indenture Agreement, I, Leopoldo Peralta, acting in my capacity of Finance and Administration Manager of Empresa Nacional de Autopista, S.A. (ENA), hereby notify the Indenture Trustee that for the period starting on March 25, 2020, when the government of Panama decreed a nationwide 24-hour total quarantine on its entire population, until the issuance of this letter, traffic volumes in Corredor Norte have decreased greatly and represent an average of 18% of the total daily traffic volume processed in the same highway during year 2019. Conservative estimates by analyst in the health sector explain that the quarantine measures will last at least until the beginning of June.

We consider that this event will materially and adversely affect the financial condition of ENA Norte, S.A. and ENA Norte Trust.

Given the above and based on internal monthly cash flow projections prepared for both ENA Norte, S.A. and ENA Norte Trust that take into consideration the new traffic volumes, we anticipate that it is very likely that in order to cover the quarterly debt service payments to take place on July and October of 2020, the administration will recur to making partial use of funds currently held in its Debt Service Reserve Accounts (DSRA).



Our internal cash flow projections also show that following the normalization of traffic volumes expected to take place at the beginning of the third quarter of 2020, the company will be able to replenish the DSRA to the minimum levels before the maximum six (6) months period, as per terms and conditions of bond documentation.

Please be assured that we will maintain you informed on the development of this situation.
